Rosettes will be given for First through Fourth place dogs in each jump height and each class (A & B) for each trial.

Qualifying ribbons will be given to all dogs receiving qualifying scores. Additional ribbons may be given each day to dogs achieving titles.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from the competition by action of the Trial officials. In addition, no entry fees will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the Club.

Bitches that come into season after the closing date or dogs who are lame or injured after the closing date will be refunded their entry fee minus \$5 per day if a veterinarian certificate is presented to the Trial Secretary prior to the start of the trial.

Dogs must be UKC registered to compete. Mixed breeds (AMBOR) are welcome.

No food, toys or other training aids will be permitted on the course.

Walk dogs in designated areas only. Please pick up after your dogs. Anyone witnessed not picking up after their dog will be excused from the trial weekend with no monies refunded.

Per city ordinance, all dogs must be on leash outside of the building.

Limited crating space is available in designated areas only. No ex-pens, please. Also, please stack crates wherever possible. Please bring your own chairs.

Parking is available at the rear of the building. The building is heated/airconditioned.

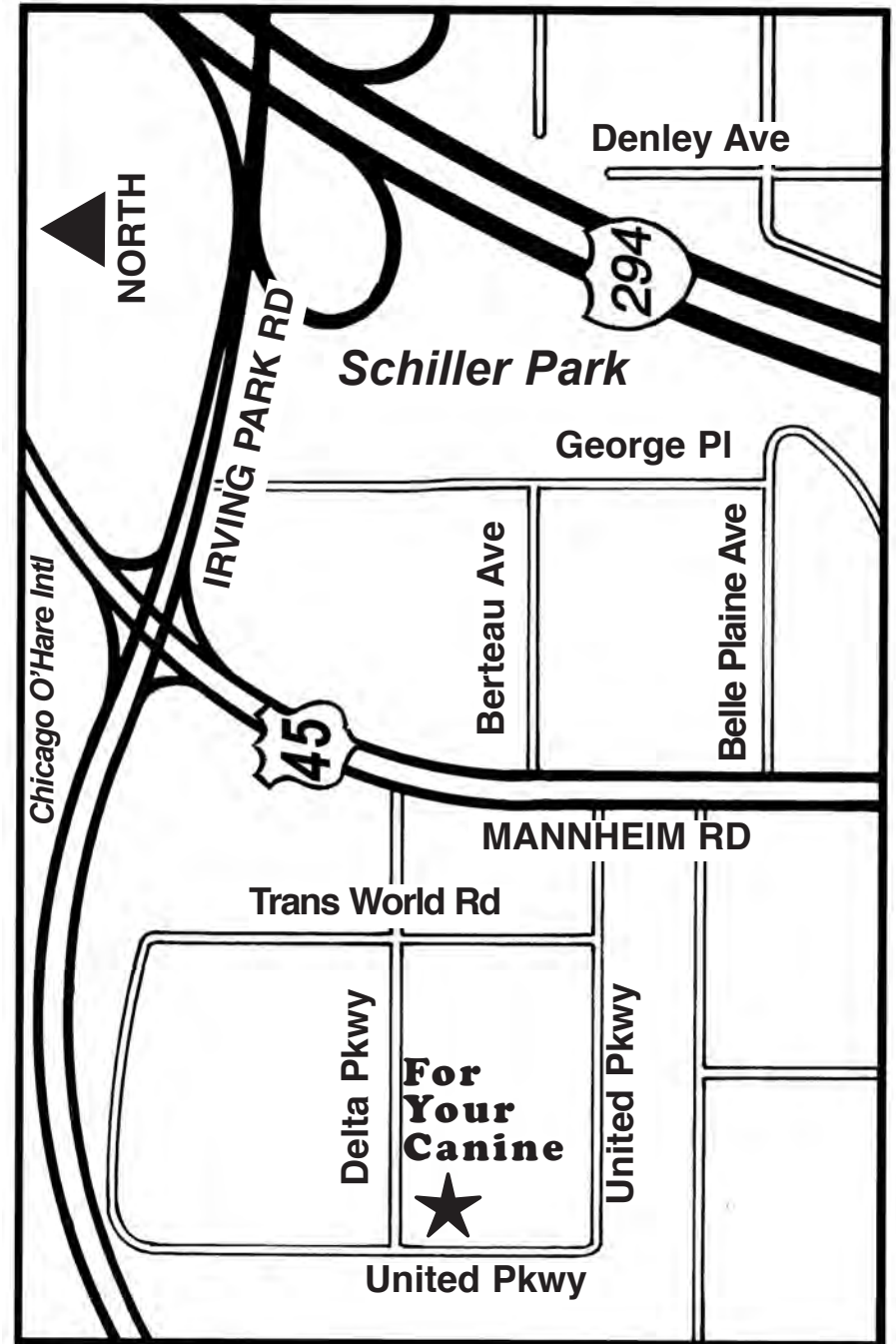

HOW TO USE THIS ENTRY FORM:

- All entries must be submitted on the current "Official UKC® Entry Form". You may use one entry form to enter the same dog in more than one activity on the same weekend.
- Use a separate entry form for each dog entered in a club's event.
- Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com or call the Dog Events Department at (269) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
- Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified. Make checks payable to host club.
- Obedience Trials, Agility Trials, Rally Obedience Trials and Weight Pull events are open to all UKC recognized breeds and mixed-breed dogs with a valid Limited Privilege number.
- We want you to keep the points earned at UKC Licensed events. Important things to remember:**
 - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Limited Privilege number.**
 - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
 - To be eligible to enter into the Breeder/Handler class, you must be one of the breeders of record, or a member of the immediate family of one of the breeders of record. Immediate family includes: spouse, parent, step-parent, child, step-child, brother or sister, so long as the handler is not a professional handler as defined by UKC Rules and Regulations.

7. Licensed Conformation classes consist of:

A. Regular Classes. Classes for intact dogs: Puppy (6 mos., under 1 yr.); Junior (1 yr., under 2 yrs.); Senior (2yrs., under 3 yrs.); Adult (3 yrs. And up); Breeder/Handler (6 mos. and up, handled by breeder or member of breeder's family); Champion; and Grand Champion.

B. Altered Classes. Classes for altered dogs. Altered Puppy (6 mos., under 1 yr.); Altered Junior (1 yr., under 2 yrs.); Altered Senior (2yrs., under 3 yrs.); Altered Adult (3 yrs. And up); Altered Breeder/Handler (6 mos. and up, handled by breeder or member of breeder's family); Altered Champion; and Altered Grand Champion.

C. Junior Showmanship Classes. Consist of: Pee Wee (over 2 yrs., under 4 yrs.); Sub-Junior (4 yrs., under 8 yrs.); Novice Junior, Open Junior (8 yrs., under 13 yrs.); Novice Senior, Open Senior (13 yrs., under 18 yrs.)

WAIVER

All events are held under the Official Rules and Regulations of the United Kennel Club, Inc. Absolutely no alcoholic beverages, illegal drugs or firearms will be allowed on the grounds or in the buildings on the day of a UKC Licensed event. UKC, its agents and employees, and the host club assume no responsibility for any loss, damage, or injury sustained by spectators or by exhibitors and handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians. UKC and the host club are not responsible for loss, accidents or theft.

By signing this form, I hereby agree to waive any claim, action, or lawsuit and further agree to indemnify and hold UKC, the host club and any approved UKC Judge harmless from any claims, actions or lawsuits resulting from my participation in this event, and any action, decision or judgment made by any UKC or host club representative or approved Judge under the official UKC Rules and Regulations governing this event. I acknowledge that the current Official UKC Rules and Regulations (Agility, Conformation, Junior Showmanship, Obedience, Rally Obedience, Terrier Race, Weight Pull) have been made available to me, and that I am familiar with their contents. My signature indicates that I understand and agree to the above and to abide by all of the current Official UKC Rules and Regulations.
